TERMS AND CONDITIONS OF BOOKING.

- A minimum deposit of 50% of total course fees is due on booking. Within 2 days of enrolment full refund will be made providing course materials are returned in unused condition.
- If a customer cancels any course 2 days after booking and prior to 6 weeks before course dates then 50% of course fees paid will be refunded. Full course fees are due a minimum of 4 weeks before course commencement date.
- Failure to attend a course or any course date/s or cancelling within 4 weeks of a booked course will be at the expense of the customer; full course fees will therefore remain due and will not be refunded.
- Haven Diving Services Staff or other attendees may take photographs and or video during our training sessions. These will also be made available to you after the session where possible.
- All courses must be commenced within 6 months of booking. Once a course has started the course must be completed within a further 6 months. If a course is not started/completed within 6 months a further payment of 50% of course fees will be required to continue the course and some remedial work by you may also be required.
- Once course dates are agreed I/we understand that if I/we wish to change course dates a charge of £50.00 per person per day or part of a day will become due. (This may also affect subsequent days of a course over several days)
- Haven Diving Services personnel and associated parties cannot be held responsible for damage/loss of property or personal belongings or injury caused by their staff or others.
- Candidates agree to abide by the PADI/DSAT orEFR safe diving guidelines and practices and/or instructions of Haven Diving Services in all training matters.

- If I have answered, “YES” to any question on the Medical Form (if my course requires one) I will arrange an appointment with my Doctor/GP with sufficient time to attend the Dr’s appointment and get his consent to dive before the above course date.
- Candidates using Haven Diving Services equipment for any course are responsible for that equipment and will be charged for any loss or damage arising from negligent/inappropriate behaviour.
- If environmental conditions or any other circumstances beyond the control of Haven Diving Services cause the course to be delayed, changed or cancelled, no liability can be accepted by the aforesaid parties for consequential loss, damage or expenses incurred by the above acts. Haven Diving Services will do, in all it’s power to resume any said courses at the earliest convenient date and availability and agreed with you.
- Quarry entry fees and boat fees are additional to course costs and are paid on each day of diving at the location.
